FOURTH ORDER OF BUSINESS

Consideration of Operation & Maintenance Expenditures for July 2013 through November 2013

Mr. Cox presented the operation and maintenance expenditures for July 2013 (\$10,579.45), August 2013 (\$7,732.57), September 2013 (\$15,691.22), October 2013 (\$29,047.05) and November 2013 (\$7,144.30) to the Board for ratification. Discussion was held on invoices related to street light repairs.

FIFTH ORDER OF BUSINESS

Consideration of Board Member Resignation

Mr. Cox presented the resignation of supervisor James Fleming from seat #2 effective December 6, 2013 to the Board for consideration.

On a Motion by Mr. Gelman, seconded by Mr. Ohlson with all in favor, the Board accepted the resignation of Board member James Fleming from seat #2 effective December 6, 2013 for the Palma Sola Trace Community Development District.

SIXTH ORDER OF BUSINESS

Discussion of Supervisor Replacement

Mr. Cox explained that the Board is authorized to appoint a replacement to fill the now-vacant seat #2 on the Board of Supervisors. The Board asked that notice be placed on the District website and in the community newsletter that the Board would consider replacements at the meeting scheduled to be held on February 27th. It was also noted that a new vice chairman would need to be selected at that meeting.

SEVENTH ORDER OF BUSINESS

Consideration of Gate Maintenance Proposals

Mr. Cox presented to the Board for consideration a proposal from USA Access Control for quarterly gate inspection and maintenance at a cost of \$140.00 per quarter. Discussion ensued.

On a Motion by Mr. Gelman, seconded by Ms. Stollman, with all in favor, the Board accepted the proposal from USA Access Control for quarterly gate inspection and maintenance at a cost of \$140.00 per quarter for the Palma Sola Trace Community Development District.

Discussion of Pond Deficiency Report and SWFWMD Recertification Report

Mr. Schappacher discussed his most recent pond deficiency report and SWFWMD recertification report for the Board. He advised the deficiencies he found are minor and do not have an effect on the operation of the system but should be addressed just the same.

Mr. Schappacher spoke about littoral shelves and the need for aquatic plantings in ponds #6 and #10. Discussion ensued.

Mr. Ohlson mentioned his observation that the mitered end sections of most of the ponds need fixing. The Board asked staff to obtain quotes for repairing and/or redesigning the structures so the Board can decide how to proceed. Mr. Schappacher discussed readjustment of the height of the control structure on pond #10.

NINTH ORDER OF BUSINESS

Discussion of Street Lights

Mr. Cox provided an update of current maintenance issues the District is facing regarding the street lights. The Board requested that quotes be obtained for painting of the bases of the street lights. It was noted that there are several trees that have to be cleared away from the lights, specifically including lights #58 and #5.

Presentation of Unaudited District Financial

Mr. Cox presented the latest monthly unaudited District financial summary as of November 30, 2013 to the Board and reviewed it for them. General discussion ensued.

Memo on Updated Rules of Procedure and Consideration of Resolution 2014-02, Setting Hearing to Adopt Rules of Procedure

Mr. Earlywine explained how the District's Rules of Procedure have been updated and must be considered for adoption by the Board, which requires a public hearing. He presented Resolution 2014-02 to the Board for consideration and advised that the resolution authorizes staff to take the necessary steps to set and hold the public hearing.

On a Motion by Mr. Gelman, seconded by Ms. Stollman, with all in favor, the Board approved Resolution 2014-02, Setting a Hearing to Adopt Rules of Procedure, for the Palma Sola Trace Community Development District.

Mr. Cox indicated the draft Rules of Procedure would be placed on the District's web site to provide an opportunity for the public to review them.

B. District Engineer

Mr. Schappacher advised the Board of some sidewalk sections in need of repair. The Board asked staff to contact the city to determine what the city's standards for sidewalk repairs are.

The Board then discussed a request from the Villas HOA asking the District to grant an easement across a lake bank adjacent to the villas for the purpose of installing drainage systems to facilitate proper water drainage from between the villas. Mr. Schappacher advised he does not see any issues as long as the pipes are adequately buried from view. At District Counsel's request Mr. Cox asked for public questions and/or comments on the topic. The only public comment was if there is any cost to the District and the resident was advised no, there is not.

On a Motion by Mr. Gelman, seconded by Mr. Parker, with all in favor, the Board authorized the granting of an easement access to the Villas for the purpose of installing drainage pipes across the banks of District-owned pond #1 to facilitate proper water drainage for the Palma Sola Trace Community Development District.
